### Overview

Directly beneath and separate from the CUI designation indicator box, is the distribution statement in its entirety. Additional markings are included as required, e. If annotated, they must be applied to all portions, to include subjects, titles, paragraphs, subparagraphs, bullet points, figures, charts, tables, etc. Good labeling of breakers is very important.
